The reason for the stylistic description is to describe the reader or to criticize the reaction to how something is written (Hiat, n.d.). The fourth is "A Feminist Stylistic Analysis in Rupi Kaur's The Sun and Her Flowers" by (Siregar et al., 2020) The purpose of this study is to analyze the position of women and men presented in texts by applying a feminist approach and also this study described the position of women as actors. The results of this study revealed gender-specific presentation at the level of words, phrases, sentences and discourse. Gender specific terms are mostly used to refer primarily to female gender.

The fifth is "Black Humor and Subversive Satire: Feminist Stylistic in The Essay I Want A Wife" by (Charuchinda, 2021). This research aims to analyze feminist stylistic features in this essay from a discourse analysis perspective and even so, Judy Syfers's essay I Want a Wife, exposed the unfair practice of patriarchy. The result showed that, in the essay contained 1) use of the pronoun 'I' in association with a collective identity in the self-introduction, 2) a shift into a phallogocentric point of view, 3) clausal repetition, 4) words with positive connotations, 5) wordplay, 6) modality, and 7) taboo breaking humor.

The sixth is "Madeline Miller's Circe: A Feminist Stylistic Approach" by (Rizwana Sarwar & Saadia Fatima, 2022). This research aims to analyze how Madeline Miller converts Circe's negative portrayal into a positive and empowered character in her retelling by challenging the stereotypical characterization of women and exposing Circe's character at the level of discourse in order to present her as a positive and empowered character.

Furthermore, the analyst should be on guard for ready-made phrases, presupposition and inference, metaphor, and jokes or humor choices when analyzing phrases to possibly unravel features that are considerably gender-biased (Mills, 1995) From this study, we analyze this song in feminist stylistics which exposes feminist messages in this song. Feminist stylistics represent gender inequality and women empowerment. We found that there is inequality between men and women since Taylor Swift's experience inspired this song.
